Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

Inspector Observations: The scoops in the bins and the bulk food bins are soiled with accumulated food debris. [CA] Wash and sanitize these items.

K33 - 2 Points - Nonfood contact surfaces not clean; 114115(c)

Inspector Observations: The table where the dish machine and dish sink meet is soiled with food particles, grease, and debris. [CA] Thoroughly clean the tables.

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: Observed a piece of wood as the platform for the slicer. This wood is deteriorated and soiled. [CA] Remove the wood from under the slicer. Bare wood is not approved for use.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations: Observed plastic bowls used as scoops and stored in the bulk food bin. [CA] Discontinue using the bowls. Use scoops with handles and store with the handles not touching the food inside.
