Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K22 - 3 Points - Sewage and wastewater improperly disposed; 114197

Inspector Observations:

Observed waste water from the 3 compartment sink leaking onto the floor and out the back door and into the parking lot. The drain pipe under the middle compartment of the 3 compartment sink is damaged.

[Corrective Action] Repair immediately.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations:

Observed rice scoop stored in room temperature water.

[Corrective Action] Store rice scoop in ice water or water at 135 degrees Fahrenheit or above.

K38 - 2 Points - Inadequate ventilation and lighting in designated area; 114149, 114149.1, 114149.2, 114149.3, 114252, 114252.1

Inspector Observations:

One of the lights in the exhaust is not working.

[Corrective Action] Ensure lights are working.

K41 - 2 Points - Plumbing unapproved, not installed, not in good repair; improper backflow devices; 114171, 114189.1, 114190, 114192, 114193, 114193.1, 114199, 114201, 114269

Inspector Observations:

Observed leak from the faucet at the 3 compartment sink.

[Corrective Action] Repair to stop the leak.

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

Back door observed left open.

[Corrective Action] Maintain back door closed to prevent entry of pest. A screen door or air curtain may be installed.
