- **Lunch is prepared daily.**
- **Lunch service is between 11:00 AM to 12:00 PM.**
  
- \*\* Note:**
- **Hot water through sinks require sometime in order to reach the required temperatures.**
  - **Food manager stated that a work order has been placed to investigate cause.**
  - **Hot water generation and distribution systems shall be sufficient to meet the peak hot water demands throughout the food facility.**
  
- **Current cafeteria manager started in August and has not completed food manager course to obtain food safety certificate.**
- **Food facilities that prepare, handle, or serve non-prepackaged potentially hazard foods shall have a valid Food Safety Certificate available for review at all times. Provide within 60 days.**

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **9/30/2024**. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
