### Major Violations

No major violations were observed during this inspection.

K07 - 3 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

**Inspector Observations: In the 2 door reach in refrigerator, measured soymilk at 45F.**

**[CA] Ensure potentially hazardous foods are held cold at 41F and below to prevent bacterial growth.**

**[SA] Operator adjusted the temperature of the 2 door reach in refrigerator, and remeasured at 41F.**

Needs Improvement - Adequate handwash facilities: supplied or accessible.
