## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K07 - 3 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

**Inspector Observations: Measured sliced tomatoes, burger patty, cheese and sliced meats between 44- 48F in sandwich prep unit. Per PIC, all the items in sandwich prep unit were restocked less than an hour ago. Items were brought from walk in cooler. Observed no lids over the unit.**

**[CA] Maintain PHFs at 41F or below.**

**[COS] PIC covered the food items with lids.**

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

**Inspector Observations: Observed open ceiling panel next to unused ventilation hood near sushi area.**

**[CA] Close the ceiling panel to prevent vermin entry.**

### Overall Comments:

**Measured shredded chicken between 56-67F in two containers stored in walk in cooler. Per manager they might be stored in distress section, however, there is no proper label to identify distress section. Per manager, deli PIC has left fro the day. Manager agreed to provide more information about the distress items to inspector at [sukhreet.kaur@deh.sccgov.org](mailto:sukhreet.kaur@deh.sccgov.org) by 4/10/24. Ensure to provide label that identifies distress section.**
