### Major Violations

**1. Grime accumulation on the door handles of all refrigeration equipments.**  
**[Corrective Action] Thoroughly clean all the door handles of all refrigeration equipments.**

**2. Grease accumulation on the side of the stove next to the deep fryer.**  
**[Corrective Action] Thoroughly clean and maintain clean.**

#### **Inspector Observations:**

**Algae build up inside the live seafood tanks.**  
**[Corrective Action] Thoroughly clean and maintain clean.**

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

#### **Inspector Observations:**

- 1. Pooling of water on the floor under live seafood tank.**  
**[Corrective Action] Do not allow water to pool on the floors.**
- 2. Grime accumulation on the wall by the dishwasher.**  
**[Corrective Action] Thoroughly clean and maintain clean.**
- 3. The floor in the walk-in cooler was observed rusted and not cleanable.**  
**[Corrective Action] The floor in the walk-in cooler may need to be replaced.**
