FINDINGS: FOUND NO COCKROACHES PRESENT DURING THE INSPECTION. THE PERSON IN CHARGE SHOWED A PEST CONTROL REPORT FROM POLARIS PEST CONTROL COMPANY. HE STATED THAT THEY WILL BE SERVICING THE FACILITY EVERY MONTH.

NOTE: THE FACILITY WAS TREATED FOR COCKROACHES AND THEN IT WAS CLEANED AND SANITIZED, PER OPERATOR.
