Major Violations

No major violations were observed during this inspection.

Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

Inspector Observations: Food safety certificate and food handler cards expired [CA] Renew the food safety certificate by 02/06/26 and food handler cards by 01/06/26.

K05 - 3 Points - Hands not clean/improperly washed/gloves not used properly; 113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f)

Inspector Observations: Employee washed hands with soap for 5 seconds [CA] All food employees shall thoroughly wash their hands and that portion of their arms exposed to direct food contact with soap and vigorously rub hands together to lather up for at least 10 to 15 seconds. They shall rinse hands with warm water followed by drying with paper towels. Employees shall pay attention to the areas underneath the fingernails and between the fingers when washing hands. – Corrected

K07 - 3 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

Inspector Observations: Front walk-in cooler at 47F [CA] Monitor and maintain unit at 41F or cooler.

K08 - 3 Points - Improperly using time as a public health control procedures & records; 114000

Inspector Observations: Time marker is used for time as public health control. However, no written policy available [CA] Provide a written policy the foods that are not kept at 41F or cooler or 135F or warmer are discarded after 4 hours.
