K06 - 8 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: Soap dispenser handwash sink in prep area was not working. [CA] Provide soap and paper towels at all handwash stations at all times. [COS] PIC replaced batteries for soap dispenser during time of inspection.

No minor violations were observed during this inspection.
