FOLLOW UP INSPECTION FROM 3-17-21 IN WHICH SEVERAL LIVE COCKROACHES WERE FOUND IN THE FACILITY'S FOOD CONTACT SURFACES, WALLS AND FLOORS.

FINDINGS: THE FACILITY WAS SERVICED BY PRESTO PEST CONTROL. THE FACILITY WAS THOROUGHLY CLEANED AND SANITIZED, PER OPERATOR. THE FACILITY'S GAPS AND HOLES ON THE WALLS AND NEAR THE WATER PIPES WERE SEALED. IN ADDITION, THE FACILITY WILL BE SERVICED EVERY MONTH, PER OPERATOR. NO COCKROACHES WERE SEEN DURING TIME OF INSPECTION. OK TO OPERATE.

FACILITY RE-OPENED / PERMIT REINSTATED

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made.
