Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: The wall-mounted soap dispenser in the kitchen was not working.
[CA] Repair the wall-mounted soap dispenser immediately.

K27 - 2 Points - Food not separated and unprotected; 113984(a-d,f), 113986, 114060, 114067(a,d,e,j), 114069(a,b), 114077, 114089.1(c), 114143(c)

Inspector Observations: A lot of open bag contents were observed on the shelf.
[CA] Store all open bag contents in properly labeled bulk containers.

Shell eggs were stored above ready to eat food products on the two door upright fridge
[CA] To prevent possible contamination, please store all raw food products below ready to eat foods, or below produce.

K30 - 2 Points - Food storage containers are not identified; 114047, 114049, 114051, 114053, 114055, 114067(h), 114069 (b)

Inspector Observations: Some food product were stored below the handwash sink.
[CA] To prevent possible contamination, please do not store any food products below the sink.

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: Surfaces and handles of some of the equipment, including the three compartment wash sink, have some dirt accumulation.
[CA] Conduct a thorough and regular cleaning on the handles and surfaces of the equipment.

K40 - 2 Points - Wiping cloths: improperly used and stored; 114135, 114185.1 114185.3(d,e)

Inspector Observations: Couple of wet/soiled wiping towels were observed on the counters and on the sinks.
[CA] Wet/soiled wiping towels must be stored in properly labeled bulk containers in between use.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: The floor sinks have some dirt accumulation.
[CA] Conduct a thorough cleaning on the floor sinks regularly.
