Inspector Observations: Observed several live cockroaches inside of bottom compartment of dairy cooler where sour cream, milk, and other foods are stored. Observed numerous dead cockroaches inside of and around sliding door to meat cold cases. Live maggots (fly larva) observed on floor near trash cans, and several dead flies observed in bottom compartments of meat cold cases. [CA] Facility shall be kept free of cockroaches, flies, and other vermin that may contaminate food and cause foodborne illness.

MEAT, DAIRY AND ANY DEPARTMENTS THAT HANDLE OPEN FOODS SHALL REMAIN CLOSED UNTIL THE VIOLATION IS CORRECTED. FACILITY MAY ONLY SELL PREPACKAGED FOODS. SEE COMMENTS ON LAST PAGE FOR CONDITIONS TO COMPLETELY RE-OPEN.

- 1) THOROUGHLY CLEAN AND SANITIZE ALL AFFECTED AREAS, ESPECIALLY IN AND AROUND MEAT AND DAIRY CASE. DISCARD ANY FOOD SUSPECTED OF CONTAMINATION**
- 2) PROVIDE PROFESSIONAL PEST CONTROL SERVICE**
- 3) SEAL GAPS, CRACKS, AND HOLES, ESPECIALLY IN ELECTRICAL PANEL BEHIND DAIRY COOLER**
- 4) UPON RE-INSPECTION, NO EVIDENCE OF VERMIN MAY BE OBSERVED, LIVE OR DEAD**

CLOSURE / PERMIT SUSPENSION NOTICE

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **9/9/2020**. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.

This notice is to inform you that as of this date the Environmental Health Permit for the above mentioned food facility is hereby suspended and all operations therewith are ordered to cease. This action is taken in accordance with Section 114409 of the California Health and Safety Code which states 'If any imminent health hazard is found, unless the hazard is immediately corrected, an enforcement officer may temporarily suspend the permit and order the food facility or cottage food operation immediately closed.'

You have the right to make a written request for a hearing within 15 days after receipt of this notice to show just cause why the permit suspension is not warranted. Failure to request such a hearing within the 15-day period shall be deemed a waiver of the right to a hearing.
