### Major Violations

No major violations were observed during this inspection.

### Minor Violations

**Inspector Observations: \*Repeat violation**

**Waste pipes extending into the floor sink under ice machine.**

**[CA] All equipment that discharges liquid waste shall be drained by means of indirect waste pipes, and all wastes drained by them shall discharge through an airgap into a floor sink or other approved type of receptor.**

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

**Inspector Observations: \*Repeat violation**

**Back door of the facility propped open.**

**[CA] Keep back door closed at all times to prevent the entrance and harborage of vermin.**

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

**Inspector Observations: Observed accumulation of food debris, dust and dirt under cooking area, around ice machine and near water heater area.**

**[CA] Clean the floors and maintain in good condition.**
