Comments and Observations

Major Violations

K22 - 8 Points - Sewage and wastewater improperly disposed; 114197

Inspector Observations: Mop sink drain appears to be clogged. Water is not draining properly.

[CA] Unclog mop sink drain to prevent sewage backup.

[COS] Maintenance was received while performing inspection. Mop sink drain is operational.

K23 - 8 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

Inspector Observations: 1) Observed 1 live cockroach in the unused proofer oven next to the stoves in the back of the facility.

[COS] Operator killed cockroach.

2) Observed dead cockroaches in the following areas:

- 1 Underneath food prep counter in the back area of the facility

- 5 in the glue trap located in the storage room

- 1 in between equipment in the front service area

3) Cockroach dropping observed underneath food prep counter in the back area of the facility

[CA] Clean and sanitize area of dead cockroaches or old droppings.

Minor Violations

K09 - 3 Points - Improper cooling methods; 114002, 114002.1

Inspector Observations: Observed food items covered with lids that are being cooled as stated by operator.

[CA] When cooling PHF's, food may be left uncovered or loosely covered to allow rapid cooling.

K27 - 2 Points - Food not separated and unprotected; 113984(a-d,f), 113986, 114060, 114067(a,d,e,j), 114069(a,b), 114077, 114089.1(c), 114143(c)

Inspector Observations: Observed box of bread stored on top of waste basket.

[CA] Discontinue storage of food on top of waste containers to prevent contamination.

K30 - 2 Points - Food storage containers are not identified; 114047, 114049, 114051, 114053, 114055, 114067(h), 114069 (b)

Inspector Observations: Single-use food containers are being reused to store food items

[CA] Discontinue the use of single-use food containers. Use only NSF approved food containers.

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: Foil is used to line the shelves of the food preparation counter.

[CA] Discontinue the use of foil to line shelves.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations: Garbage bags and retail store bags are being used to store meat.

[CA] Use only NSF approved bags to store food items.

K38 - 2 Points - Inadequate ventilation and lighting in designated area; 114149, 114149.1, 114149.2, 114149.3, 114252, 114252.1

Inspector Observations: 1) Gap in ventilation filters in the ventilation hood.

[CA] Ensure there are no gaps between the filters in the ventilation hood.

2) 2-burner stove is not underneath the ventilation hood.

[CA] Ensure all cooking equipment is underneath ventilation.

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

Inspector Observations: Food debris accumulation throughout facility.

[CA] Clean food debris from facility to prevent the harboring of cockroaches
