### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

**Inspector Observations: There is not any employee that has a food safety certificate. [CA] At least one employee must have a FSC.**

K23 - 3 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

**Inspector Observations: Observed rodent droppings on the kitchen floor. [CA] Clean up the droppings and take effective measures to eliminate rodent entrance and any that are in the facility. According to the manager he will call the pest control company to come out for an extra service and provide more glue boards to monitor if the activity is new or old.**
