Inspector was contacted by PIC to conduct a follow up inspection to reopen the facility.

Observed several rodent droppings behind three door refrigerator. All other evidence of rodents have been removed. Per PIC, the facility has been cleaned and sanitized with bleach. All equipment was moved out to the back of the facility, per PIC it will be clean and sanitized prior to being used and placed back in the kitchen.
