Facility previously closed due to major hot water violation.

Upon follow up inspection:

- -Hot water at hand sink and 3 compartment sinks observed at 120F.
- -Food was in good condition. Raw chicken observed contained and not contaminating other food items.
- -Unable to verify major hot and cold holding violation correction. Facility was not prepping food or in operation at time of inspection. Operator shall ensure PHFs are placed into cold holding units or use ice bathes to maintain temperature.

Facility is reopened. Continue to work on violations from routine inspection.
