Major Violations

No major violations were observed during this inspection.

Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

Inspector Observations: Food safety manager certificate expired in July.

[CA] Food facilities that prepare, handle, or serve non-prepackaged potentially hazard foods shall have a valid Food Safety Certificate available for review at all times.

K33 - 2 Points - Nonfood contact surfaces not clean; 114115(c)

Inspector Observations: Debris built up on the side of the self service beverage.

[CA] Clean and maintain.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations: Broken gasket observed at walk-in freezer.

[CA] Repair gasket.

K43 - 2 Points - Toilet facilities: improperly constructed, supplied, cleaned; 114250, 114250.1, 114276

Inspector Observations: Toilet tissue paper is not stored in paper dispenser.

[CA] Toilet tissue shall be provided in a permanently installed dispenser at each toilet.

Loud noise from fan in walk-in fridge. Per PIC, technician was contacted and will come fix it soon. Cold holding temperature was OK at the time of inspection.
