Inspector Observations: There are no paper towels at the hand sink paper towel [CA] Provide paper towels in the dispenser at he bathroom hand sink.

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: The beverage holders in the walk in have mold on them. [CA] Clean the plastic shelf beverage holders.

K43 - 2 Points - Toilet facilities: improperly constructed, supplied, cleaned; 114250, 114250.1, 114276

Inspector Observations: The toilet paper is not in the dispenser. The restroom is not kept clean. [CA] Keep the toilet paper in the dispenser and clean the restroom.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: The floor in the walk in has garbage. The wall/door in the restroom are soiled. [CA] Clean the floor and walls and door.
