## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

**Inspector Observations: Observed cardboard was being used to line shelf in rear storage area.**  
**[CA] Discard cardboard lining; all surfaces must be smooth, durable, and easily cleanable.**

K41 - 2 Points - Plumbing unapproved, not installed, not in good repair; improper backflow devices; 114171, 114189.1, 114190, 114192, 114193, 114193.1, 114199, 114201, 114269

**Inspector Observations: Under the ice machine: observed lack of one inch air gaps between drain pipes and floor sink.**  
**[CA] Maintain a minimum one inch air gap between the drain pipes and the floor sink to prevent wastewater backflow.**
