Overall Comments:

This is a follow-up inspection for the routine inspection conducted on 12/04/2024:

Observations:

K06: The front hand sink continues to lack of hot water. Staff were observed washing hands in the right most compartment of the three compartment sink. Per PIC they need some time to fix.

K07: All PHFs were observed at 41°F or below. Boba pearls were time marked for TPHC.

Continue to correct all pending violations. A follow up inspection may be required to determine compliance with violation K06 and K21.

Note: The first follow up inspection is free of charge. Any and all subsequent follow up inspections shall be charged at the approved hourly rate of \$298.00/hr, minimum of one hour, during normal business hours: Monday through Friday 7:30am to 4:30pm or \$645/hour minimum two hour during non business hours, and upon inspector availability.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **12/20/2024**. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
