Major Violations

No major violations were observed during this inspection.

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: Found warm water knee lever at hand wash station located at front station unable to turn off due to broken lever. To turn off water, facility are to turned off hot water valve. Note: Another hand wash station is located at decoration station. [CA] Ensure cold/warm water is provided at all times. [SA] Operator directed to use hand wash station located at decoration station until repair is made to sink.
