Inspector Observations: the inside of the ice machine has accumulation that needs to be cleaned off. [CA] Thoroughly clean and sanitize the inside of the machine.

Inspector Observations: Observed beverages on the floor throughout the facility. [CA] Please remove from the floor and place on shelves/racks. Dunnage racks may be helpful.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: The floor in the walk in has accumulation of debris in corners and under items. [CA] Clean the floor.
