Major Violations

No major violations were observed during this inspection.

Inspector Observations: CLOTH TOWEL ON COUNTER [CA] Wiping towels shall be stored in sanitizing solution of an approved concentration when not in use (100 ppm - chlorine, 200 ppm - quaternary ammonium).

K43 - 2 Points - Toilet facilities: improperly constructed, supplied, cleaned; 114250, 114250.1, 114276

Inspector Observations: OPEN TOILET PAPER ROLL IN THE RESTROOM IMPROPERLY STORED [CA] Toilet tissue shall be provided in a permanently installed dispenser at each toilet.
