Inspector Observations: FOUND NO LABEL FOR THE INDIVIDUAL DESERT CUPS. [CA] Food prepackaged in a food facility shall bear a label with the following: 1) common name of the food, 2) list of ingredients in descending order of predominance by weight, 3) quantity of contents, 4) name and place of business of the manufacturer, packer, or distributor.

Inspector Observations: FOUND THE DOOR OF ONE OF THE COOLING UNITS IN DISREPAIR. [CA] REPAIR THE DOOR.

Inspector Observations: FOUND A COUPLE OF CEILING TILES MISSING IN THE BACK OF THE FACILITY. [CA] PROVIDE THE CEILING TILES.
