**Inspector Observations: Observed containers (whipped cream cans and condiments) stored on ice used to serve customer. [CA] Remove all items from the ice machine and ice bins.**

**Observed an uncounter dishwasher and TurboChef oven not being used in the facility. [CA] Remove all unused equipment. If facility would like to use these equipments, plans must be submitted for review.**
