Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations:

The liquid soap dispenser and the handwash sink was not dispensing properly due to low battery. Employees were still able to get soap by pressing at bottom. [Corrective Action] Ensure automatic dispenser is always working properly. [Corrected on Site] Person in charge replaced the batteries and dispenser is working properly.

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

Inspector Observations:

Observed employee rinsing knife in the handwash sink then proceeding to wipe with cloth. [Corrective Action] The handwash sink is used for handwashing only. Clean and sanitize utensils at the warewash area.
