Comments and Observations

Major Violations

K07 - 8 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

Inspector Observations: *Observed the white sauce and gravy to be at 120 and 110 degrees F. They were both in double containment. [CA] The manager stated that it will be thrown away shortly at 1p.m. and made at 9 Do not keep them in this manner as it is not holding at proper temperatures of 135 degrees F and above. If items are thrown away at the 4 hour mark then time coding records must be kept.*

Minor Violations

K40 - 2 Points - Wiping cloths: improperly used and stored; 114135, 114185.1 114185.3(d,e)

Inspector Observations: *T=Observed 5 used wiping towels on the table tops at the cook line. [CA] Keep the used wiping towels in sanitizer between each use or discard since they are disposable.*

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: *Observed the wall in the cookline/food prep area to be deteriorating. [CA] Repair/repaint the walls where needed.*
