Inspector Observations: The fan and ceiling in the walk in refrigerator have accumulated black dust and mildew accumulation. [CA] Thoroughly clean the walk in.

**Inspector Observations: Observed the back storage room floor to have accumulation against the walls and under pellets. [CA] Clean the storage room floor under items and against the walls.
The janitors room ceiling has brown accumulation. [CA] Clean the splatters and accumulation.**
