### Major Violations

**Inspector Observations: Dust accumulation observed on walk-in cooler fan covers. Food residue observed on shelves.**

**[CA] Nonfood-contact surfaces of equipment shall be kept free of an accumulation of dust, dirt, food residue, and other debris.**
