Inspector Observations: Rodent droppings observed on ledge behind freezer and behind equipment storage shelf. [CA] Clean and sanitize area of dead cockroaches or old droppings. Ensure to routinely monitor for new vermin activity. Seal any vermin entries and remove any attractants.
