Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

Inspector Observations: Not all of the employees have food handler card available. [CA]
[CA] Each food handler shall maintain a valid food handler card for the duration of his or her employment as food handler. A valid food handler card shall be provided within 30 days of after the date of hire.

K29 - 2 Points - Toxic substances improperly identified, stored, used; 114254, 114254.1, 114254.2

Inspector Observations: Observed spray bottles with cleaners in them not labeled. [CA] Label the bottles with the contents. [COS] The contents was written on the bottles after inspection.

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

Inspector Observations: The dish washing machine shows 0ppm chlorine. [CA] The machine must read at 50ppm chlorine. According to the employee they have not been using it and they are using the 3 compartment sink.

K39 - 2 Points - Thermometers missing or inaccurate; 114157, 114159

Inspector Observations: Observed no thermometer in a prep refrigerator. [CA] Each unit must have a thermometer in it.

Fried chicken is made and discarded after 3 hours according to the owner. There is a timer there for when the discard time is up.
