## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

**Inspector Observations: Paper towels maintained on top of toilet tank.**

**[CA] Paper towels shall be stored inside the dispenser to prevent potential contamination.**

K21 - 3 Points - Hot and cold water not available; 113953(c), 114099.2(b), 114163(a), 114189, 114192, 114192.1, 11419

**Inspector Observations: Hot water at the three-compartment sink fluctuates between 90F to 100F.**

**[CA] Hot water shall be supplied at a minimum temperature of at least 120°F measured from the faucet throughout facility except at handwash sinks.**

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

**Inspector Observations: Observed ice scoop used to pack bagged ice maintained on top of ice machine not in a sanitary manner.**

**[CA] Properly store utensils and equipment in a clean and sanitary manner.**

K41 - 2 Points - Plumbing unapproved, not installed, not in good repair; improper backflow devices; 114171, 114189.1, 114190, 114192, 114193, 114193.1, 114199, 114201, 114269

**Inspector Observations: Observed steady leak at the faucets of the three-compartment sink when water is turned on. Faucets also observed heavily encrusted with calcified matter.**

**[CA] Repair plumbing fixture and maintain in clean and good repair.**

Needs Improvement - Hot and cold water available.

Needs Improvement - Food contact surfaces clean, sanitized.
