Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K23 - 3 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

Inspector Observations: Observed a dog in the facility. [CA] Pets are not allowed in the facility. [COS] The manager spoke with the customer and the dog was taken outside.

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: Observed the inside upper stainless panel of the ice maker to have a small piece of lettuce stuck to it. [CA] Clean the lettuce off of the inside panel of the ice machine. [COS] The manager removed the panel and washed and sanitized it.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Observed the floor to be missing grout in areas in the kitchen and broken tiles near the potato wash area. [CA] Repair the floors where missing grout or broken tiles are observed.
