Comments and Observations

Major Violations

K06 - 8 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: All hand wash stations within the back of the facility are missing paper towels at the time of inspection.

[CA] Hand wash stations must be fully stocked and operational at all times.

[SA] A roll of paper towels is next to hand wash stations.

Minor Violations

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Floors within the kitchen area have heavy flour build up and pooling of water noted behind the mixing machine.

[CA] Regularly clean under equipment to prevent accumulation of debris.
