Comments and Observations

Major Violations

K07 - 8 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

Inspector Observations: Various PHF held in undercounter refrigerator at service area measured >41F, <135F, <2hrs.

[CA] PHFs shall be held at 41°F or below or at 135°F or above. Per PIC, PHF was placed in the undercounter refrigerator approximately 2 hours prior to the inspection. PHF Moved to the walk-in refrigerator for rapid cooling.

Minor Violations

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: Ambient temperature of refrigerator at service area measured at 65F. [CA] Refrigeration must be capable of maintaining PHFs at 41°F or below. [COS] Refrigerator plugged in.
