Major Violations

No major violations were observed during this inspection.

K23 - 3 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

Inspector Observations: Observed fruit flies by bar warewash machine; particularly concentrated on a leftover dessert dish. [CA] Eliminate fruit flies from facility; recommend working with professional pest control. Discontinue leaving dirty dishes out.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations: Observed several CO2 tanks not tied up to a rigid structure. [CA] Ensure CO2 tanks are chained to a rigid structure.
