Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K07 - 3 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

**Inspector Observations: Cooked chicken (warmer) and milk (preparation table) measured >41F<135F.
[CA] PHFs shall be held at 41°F or below or at 135°F or above.**

K22 - 3 Points - Sewage and wastewater improperly disposed; 114197

**Inspector Observations: Condensation from refrigerator equipment dripping on boxed food in walk-in refrigerator.
[CA] Condensation line from walk-in refrigerator shall drain into an approved plumbing system. Repair refrigerator equipment**

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations: knife found stored propped between preparation refrigerator and preparation table. [CA] Properly store utensils and equipment in a clean and sanitary manner.

Co2 tank is not secured to a rigid structure.

[CA] All pressurized cylinders shall be securely fastened to a rigid structure.

Ice cream scoop is not stored in running water.

[CA] Utensils shall be stored in the following manner: 1) in the food with their handles above the top of the food and the container, 2) in running water, 3) in a container of water at 135°F or above, 4) at room temperature if washed within 4 hours of initial use.
