Inspector Observations: Observed sewage backup near the ice machine at the front counter. Multiple location throughout the kitchen area with signs of sewage backup. Employees stepping on sewage and walking throughout the facility. [CA] Liquid waste shall be disposed of through the approved plumbing system and shall discharge into the public sewerage or into an approved private sewage disposal system.
