**Inspector Observations: In the self-service area, in the 3 door reach in refrigerator, observed employee food items stored with food that is for sale. [CA] Ensure employee food items are stored separately and the area is labeled.**

**Inspector Observations: Facility permit expired as of 04/01/2024. [CA] A food facility shall not be open for business without a valid health permit.**


