Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

Fruit flies or gnats observed on the dough press machine in the kitchen.

[Corrective Action] Eliminate fruit flies or gnats using safe methods.

K27 - 2 Points - Food not separated and unprotected; 113984(a-d,f), 113986, 114060, 114067(a,d,e,j), 114069(a,b), 114077, 114089.1(c), 114143(c)

Inspector Observations:

Observed open bags of flour in the kitchen.

[Corrective Action] Close bags after use or store bags of flour in a container with a tight fitted lid.

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

Inspector Observations:

Screen cover at the back door does not completely cover the opening of the door.

[Corrective Action] The screen cover shall completely cover the entire opening of the door.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations:

Heavy flour accumulation on the floor under the dough press machine in the kitchen.

[Corrective Action] Thoroughly clean and maintain clean.
