THE FACILITY IS DEVOID OF FLIES. THE FRYER HAS BEEN REMOVED FROM THE PREMISES. HAND WASHING WAS DEMONSTRATED TO BE DONE PROPERLY. FOOD TEMPERATURES ARE WITHIN NORMAL RANGE.

CONTINUE WORKING ON OBTAINING THE REST OF THE FOOD HANDLER'S CARDS FOR THE FOOD EMPLOYEES.

OK TO RE-OPEN.

THIS IS THE SECOND RE-INSPECTION THEREFORE, IT WILL BE CHARGED AT \$290 PER HOUR, MINIMUM ONE HOUR.

FACILITY RE-OPENED / PERMIT REINSTATED


