### Major Violations

**[Corrective Action] Secure the pressurized cylinder to a rigid structure.**

#### **Inspector Observations:**

**Observed water leak at the cold water knob at the 3 compartment sink.**

**[Corrective Action] Repair to stop the leak.**

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

#### **Inspector Observations:**

**Observed grime on the wall at the mop sink.**

**[Corrective Action] Thoroughly clean and maintain clean.**
