Major Violations

No major violations were observed during this inspection.

K07 - 3 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

Inspector Observations: Grab n go cooler measured to have ambient temperature of 44F and cheese stick at 43F in middle right shelf. Cooler observed to have boxes blocking fans. [CA] Keep PHFs at 41F and below for cold holding. [COS] Boxes were moved and after 30 minutes ambient temperature measured to be 40F.
