Major Violations

No major violations were observed during this inspection.

Inspector Observations: Observed some small meat particles on the table and saw in the meat department that was not yet open this morning. [CA] Discontinue leaving the equipment with particles on it. [CA] The butcher came in and sanitized before using.

K23 - 3 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

Inspector Observations: Observed gnats in the store. [CA] Take effective measures to eliminate the flies. The front door is to be kept closed due to the open food prep and insects.
