Note: 1. The facility was closed on 11/17/23 due to cockroach infestation. During the time of this inspection, no dead or live cockroaches were observed in the front soda dispenser, service counter, or back in the kitchen areas. Therefore, the facility is open for service. However, multiple live and dead fruit flies were observed below the front soda dispenser and in the kitchen areas. Conduct a thorough cleaning of the floor sinks and eliminate flies from the facility by a legal method.
