Facility has expanded operations to the unit next door previously CALIBEAR FA0285553 without a valid health permit. New space is being used as a counter for making coffee and tea, and has a display refrigerator used for storing PHFs.

Observed an ice machine and a back room with a dishwasher, a 3-comp sink and a prep refrigerator.

Immediately cease and desist all food operations within the expanded area. Equipment located in this area shall not be used until approved by this agency.

Submit plans to Santa Clara County Environmental Health for the installation of new equipment within 2 weeks.

Facility is found to be in continued operation without a permit may incur a penalty of three (3) times the operating permit fee, and fee(s) for re-inspection(s) charged at the current hourly rate approved by the Santa Clara County Board of Supervisors. Penalties and fees incurred due to enforcement activities must be paid in full prior to the issuance of an operating permit

Subsequent follow-up inspection after first follow-up shall be billed \$298/hour, minimum one hour, during normal business hours (Monday - Friday, 7:30 AM to 4:30 PM), and \$645 for a minimum of two hours, during non-business hours, and upon inspector availability.


When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **2/11/2026**. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
