- In the kitchen area, at the storage area, observed 2 live cockroaches by the large upright reach in freezer. Operator moved upright reach in freezer and observed cockroach activity below and underneath reach in freezer.

- Facility is currently showing signs of active infestation. Continue to clean and sanitize areas with cockroach activity.
- Operator to remove all equipment by walls and clean floors below equipment to prevent harborage of vermin.

- Follow-up inspection scheduled for Wednesday 3/24/2021.

- Observed hot water provided at handwash stations in the kitchen area.

CLOSURE / PERMIT SUSPENSION NOTICE
