Major Violations

No major violations were observed during this inspection.

Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

Inspector Observations: The food safety certificate is expired. [CA] At least one employee must have a food safety certificate and all others that prepare food must have a food handlers card.

K19 - 3 Points - Non-compliance with consumer advisory for raw or undercooked foods; 114012, 114093

Inspector Observations: Rare items are available upon request. [CA] Provide the consumer advisory notice on the menu.

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: The handles of the refrigerators have accumulated food particles underneath. Observed towel wrapped around handles. [CA] Clean and sanitize them. Remove the cloth towels from the refrigerator door handles.
