Comments and Observations

Major Violations

K23 - 8 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

Inspector Observations: Observed a cockroach on the floor near back door. Appeared to just come in from the open back door. [CA] Take effective measures to eliminate the insects from coming inside. Protect all food from possible contamination. [COS] The employee killed the cockroach.

Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

Inspector Observations: There is not a food safety certificate. [CA] At least one employee must have a food safety certificate and all others that prepare food must have a food handler card.

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

Inspector Observations: There were pH test strips shown as sanitizer test strips by the employees. [CA] Obtain and use the chlorine test strips each time after making the towel bucket and after washing and rinsing the dishes.

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: Observed a couple of unused large equipment in the facility. [CA] Remove the unused equipment from the facility.

K38 - 2 Points - Inadequate ventilation and lighting in designated area; 114149, 114149.1, 114149.2, 114149.3, 114252, 114252.1

Inspector Observations: Observed several lights out in the kitchen. Kitchen and storage is very dim. [CA] Replace the light bulbs that are out and missing. (Repeat violation)

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

Inspector Observations: Observed the front and back door left open. [CA] The doors must be kept closed or a screen door or air curtain must be installed.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Observed the floor to have accumulated food particles and debris. [CA] Thoroughly clean the floors mostly under and behind equipment.

The FRP is coming off where the bike is hanging. [CA] Remove the bike and repair the wall.
